A quorum was declared and President Johnnie Terry called the meeting to order by at 4:10 p.m.

I. Visitors Comments

II. Approval of Minutes

III. Reports

A. Treasurer

No report. Nothing has changed. Keep moving.

B. Vice President

C. President

First, Johnnie reported that Josh Breese declined the \$100 donation for SCCP training. Second, SCFA is finally in compliance with CCA and CTA, officially protecting the Board.

Third, at the CCA Conference, Jennifer and Johnnie presented about preparing for Janus. We need to inoculate our members regularly – one-on-one – and we need to start building leaders for SCFA. Additionally, once we lose Fair Share fee payers, we may face a membership bleed, but they can only disenroll from the Union by coming to us in writing; thus, they are encouraging us to talk to them. This is an opportunity to discuss their Union rights and what they face to lose. Fourth, CTA has announced that “[i]t is crucial that fees collected after the SCOTUS decision be escrowed and refunded to fee payers promptly if SCOTUS outlaws such fees.” Fifth, Jennifer and Johnnie plan to set up a student CTA chapter (a student club on campus). Student will pay \$30 per year in dues, \$5 of which is rebated to the student club on campus. Sixth, Johnnie and Jennifer met with a CTA staff member about Dual Enrollment issues at Sierra College. She

suggested an ongoing meeting and a grant. We will be the first campus in the state to work with union representation from high school districts and SCFA. Finally, election ballots are counted May 18th so we will schedule a May 23rd meeting.

D. Executive Board Members

Michelle suggested we need a date for the office clean-out and move to the new office.

Judith reported about a session on mental illness at a conference because of concerns with pot smokers coming to class high. Judith suggested that faculty needs guidance with students who come to class high regarding student behavior. Judith requested a Flex session about marijuana use and new laws and student conduct.
