IV. Secretary Report

a. Update on Officer Contact List: Secretary has updated Officer Contact List and has distributed it to officers.

V. Treasurer's Report:

- a. Treasurer will be contacting officers to complete W-9s.
- b. If there are any outstanding or future expenses including upcoming conferences and professional development events, please contact the Treasurer as soon as possible.
 - i. Communications Officer: The website was purchased by another company (\$20/year) and caused problems with the website.
- c. There is a need for postage stamps and envelopes for union business purposes.

VI. Interim Chief Negotiator's Report:

- a. Update on 10/12 Pay election process (an option that allows faculty employees to choose if they want to receive their annual salary over 10 months or 12 months of paychecks): VPHR (Vice President Human Resources) is still investigating the issue and the reason for this process may involve potential overpayment. As a safeguard, The District has to ask academic year employees to annually confirm if they would prefer the 10-month pay or 12-month pay.
- b. Update on Data Forensics Breach of Information: For employees whose information has been compromised, they should have received a letter but the letter may be coming from a third party company.
 - i. Participant 1: This came up at the Strategic Council meeting; it was disheartening that this issue was downplayed loosely. SCFA has raised the level of severity for this issue. Some also may have been notified by their banks already. The District needs to take more initiative on communicating more clearly. The District also shared that they will work with Marketing to make a more concerted effort to take this seriously and will ask for the Information Technology Services (ITS) department to report back.
 - Chief Negotiator: The VPHR takes this issue very seriously too. The world we live in today, we need to respond and take data and information breaches seriously.
 - ii. Participant 2: How many people were affected? What are they doing to prevent this in the future?
 - 1. Participant 1: We did ask ITS to have them follow up on this issue.

- 2. Chief Negotiator: We had a conversation with the Academic Senate to talk about technology instructions and how we are resourcing our ITS department to have the systems in place.
- 3. Participant 1: Sierra College will work with California Community Colleges Chancellor's Office (CCCCO) to pilot a program where there will be a simulation attack to find holes in the system.
- 4. President: This topic will come up at Academic Senate will be brought up at the November 9th meeting
- iii. Participant 3: There were system updates that happened during the Withdraw deadline this was poorly timed. What's going on?
- iv. Participant 4: How are we being hacked? Why aren't we being trained how to avoid these?
 - Participant 1: This is a much more complex issue than just a simple email training. <u>Multi Factor Authentication (MFA)</u> is becoming more robust to try and avoid security breaches. However, Sierra College will be going through the CCCCO Pilot program to find holes in its security.
- c. Update on Part Time Faculty Annual Load Percentage: SCFA brought up concerns at Negotiations and it was discovered that through California Education Code, a faculty cannot have more than 2 semesters over 65% load over a 6 semesters year period. VPHR verified this information, if anyone wants to know the specific California Education Code, please see VPHR for assistance.
