 - i. Participant 3: I just wanted to recognize the extra effort the VP puts into providing updates and information to SCFA

 - iii. Participant 3: I am also concerned about the issues with the calendar change with the week off in the middle of the term and how it impacts PT faculty negatively. There also used to be 8 week sessions without a break in the middle. There used to be an 8 week and 8 week or 7 week and 7 week without a break. I would like to propose no break, they used to be able to do it and run their reports. I do not see why there needs to be a disruption to the schedule. This creates a financial problem that affects part-time (PT) faculty. I would like to see real figures and facts about the success data with this plan.
 - iv. Participant 1: Thank you for the information Judith. There is still not an email that next year's Spring 2024 calendar has changed. I don't understand why a message was sent out to the many faculty that were

not in the know; when there is a significant change of the calendar regarding the matter, there should be some information sent out. I think there is going to be a lot of questions and concerns when their obligations and commitments

- v. Participant 4: Will PT faculty be paid during the break?
 - 1. Participant 3: No they are not, unless SCFA wants to negotiate
 - 2. Vice President: No, they are not.
 - 3. Participant 3: They arre only paid for when they're there and cannot be paid for unemployment for that week. PT faculty cannot be paid that.
- vi. Participant 5: FT faculty teach 175 day contracts, we do not get compensated for Spring Break. I think you're seeing a reduction in PT offerings due to enrollment dropping and the pandemic has made it worse. I think what you're seeing is that the offerings are reducing.
